## Itinerary

A detailed day-by-day itinerary will be handed out during the "Welcome Meeting" at the start of the workshop.

This is not a workshop where you spend most of your daylight shooting hours sitting in a classroom. We get you up and out to make the most of each and every day to capture as many great photo opportunities as possible.

Day 1: Arrival - Meeting in hotel at around 18 clock, tour planning and first group dinner. Overnight in Reykjavik.

Day 2: Þingvellir national park, Kaldidalur, Langjökull Glacier, Hraunfossar, Barnafossar waterfalls. Sunset in Kolugljufur waterfall in canyon. Overnight on the north coast

Day 3: Hvitserkur rock on black sand beach. Horses, horses, horses, Godafoss waterfall, Myvatn lake. Overnight Myvatn

Day 4: Full day in Myvatn area. Lake area, lava fields, geothermal pools, Hverir, Krafla, Namaskard, Leirhnjúkur. Viti. Overnight Myvatn

Day 5: Full day in Myvatn area. The major waterfalls, Aldeyjarfoss and Godafoss in Skjalfandaljot. Crater in Myvatn. Overnight Myvatn

Day 6: Travel from Myvatn north coast. Dimmuborgir, Horses, Hraundrangar, Waterfall Reykjafoss. Overnight in Bakkaflof

Day 7: Travel Kjölur into the central highlands, geothermal area Hveravellir (hot pools and steam vents). Geothermal mountain area Hveradalir in Kerlingarfjoll. Waterfall Gygjafoss. Overnight in the central highlands

Day 8: Kerlingarfjoll geothermal area, travel Kjölur to Skálpanes, Hvítársíða, Waterfall Gullfoss, Geysis. Group dinner and overnight in Reykjavik

Day 9: Reykjavik - Airport transfer to KEF

## WORKSHOP TERMS AND CONDITIONS

### WAIVER, INDEMNIFICATION, LIABILITY RELEASE, FINANCIAL RESPONSIBILITY, AND CANCELATION POLICY AGREEMENT

---

Please read the following document carefully. Each individual participating in a photography workshop or traveling with a participant must submit a signed copy of this form as part the registration process.

Participants under 18 years of age must also include the signature of a parent or guardian, who is signing this agreement on the behalf of the minor.

**\*\*\*THIS AGREEMENT AFFECTS YOUR RIGHTS. PLEASE READ.\*\*\***

1. In consideration of my participation in the photography workshop(s) (hereinafter "Workshop") of Custom Photo Images (hereinafter "CPI"), whether on the premises of CPI or elsewhere, I hereby accept and agree to this Workshop Terms and Conditions and Waiver, Indemnification, Liability Release, Financial Responsibility, and Cancellation Policy Agreement (hereinafter the "Agreement") whereby I release and discharge and agree not to sue CPI, and/or CPI's owners, heirs, agents, employees, independent contractors, administrators, successors, executors, instructors, outfitters, facilities, or other providers, and/or assigns ("hereinafter "Affiliates"), from all responsibility to me, my heirs, agents, employees, administrators, successors, executors, and/or assigns for anything which may occur, directly or indirectly, from my participation in the Workshop and from all actions, causes of actions, claims, suits, controversies, agreements, promises, damages whether consequential or incidental, and judgments, including attorneys' fees and costs, whatsoever, in law, admiralty, or equity that may arise from my participation in the Workshop and whether caused by acts, errors, or omissions of CPI, its Affiliates, instructors, staff, tour guides, and anyone and anything in any way associated with the Workshop. It is my understanding that the territory for the Workshop and for which this Agreement applies is worldwide, including but not limited to all oceans, inlets, intracoastal waterways, beaches, lakes, rivers, and all other waterways. This Agreement extends to my use of any and all related facilities and equipment, including, but not limited to, my use of CPI's cameras, lenses, underwater housings, and any and all other equipment, and for while riding as a passenger in a waterborne vessel, automobile, or other conveyance operated in conjunction with the Workshop. I fully accept for myself, my heirs, agents, employees, administrators, successors, executors, and assigns, all the risks involved in the Workshop and the Workshop's surrounding activities, including but not limited to any accident or injury which may occur while I am traveling to or from the Workshop and associated events.
2. I understand that this is an all-purpose Agreement and as such there may be sections in this Agreement that do not apply to my particular Workshop and/or the activities I am undertaking or will undertake with CPI and its Affiliates. I accept the use of this all-purpose Agreement and agree to all of the terms applicable to me and for the Workshop and/or activity in which I am engaged or in which I plan to engage. I understand and agree that this entire Agreement applies to me regardless of the type of Workshop in which I participate.
3. The Workshop and activities of CPI and my participation in those activities may result in loss to me and to others who might wish to make claim through me, including death, personal injury, property damage, and other losses. I ACKNOWLEDGE AND EXPRESSLY ASSUME ALL RISKS OF PARTICIPATING IN THE WORKSHOP in which I am about to engage which include without limitation, many perils, known and/or unknown, including but not limited to the possibility of serious injury and/or death to my person and/or my property, as well as to the possibility of illness, accident, travel hazards by air or vehicle, incidents with native and non-native wildlife, insects, flora, changing water flow, tides, currents, wave action, and boats' wakes; collision with any of the following: other participants, my watercraft, other watercraft, man-made or natural objects; wind shear, inclement weather, lightning, variances and extremes of wind, weather, and temperature; changes to my sense of balance, physical condition, ability to operate equipment, swim, and/or follow directions; collision, capsizing, sinking, or other hazard which may result in wetness, injury, exposure to the elements, hypothermia, impact of the body upon the water, injection of water into my body orifices, and/or

drowning; the presence of insects and marine life forms; equipment failure or operator error; heat- or sun-related injuries or illnesses, including but not limited to sunburn, sunstroke, or dehydration; fatigue, chill, and/or dizziness which may diminish my reaction time and increase the risk of an accident; being in an outdoor environment and that accordingly I and my equipment may be exposed to dangers and hazards both natural and man-made; falling; falling rocks; getting lost; traveling in rough terrain; possible creek crossings; interaction with stock animals including horses and cattle; forces of nature such as lightning strikes; inadequately marked trails; camp injuries; infectious stomach ailments; impure water; and/or allergic reactions.

4. I possess the necessary level of physical fitness, skill, and training to participate in the Workshop. This includes, if applicable to my Workshop, personal knowledge required of a scuba diver and that I possess a minimum scuba certification or licensure that permits me to participate in scuba-related activity. I acknowledge that scuba diving is a dangerous activity and involves the risk of serious injury and death and property damage. I further acknowledge that diving with compressed air involves certain risk and injuries that can occur which may require treatment in a recompression chamber or other facility which may require a great distance of travel. I understand that the open water diving trips which may be a part of the Workshop may be conducted at a site that is remote, either by time or distance or both, from a recompression chamber or medical facilities.
5. I DECLARE THAT I POSSESS THE STANDARD OF COMPETENCE NECESSARY FOR THE WORKSHOP AND THAT I AM PHYSICALLY FIT TO PARTICIPATE IN AN ACTIVITY OF THIS TYPE. I understand the physical requirements of participation in the Workshop activities and affirm that I meet these requirements, and that my physical and mental health is good, and that I am not under a doctor's care for any condition that might endanger me or other participants. CPI reserves the right to request a doctor's statement of good health from me and if I can not or do not provide this statement from my doctor, CPI may in its sole and unfettered discretion refuse my participation in the Workshop.
6. I UNDERSTAND AND ACKNOWLEDGE THAT THE WORKSHOP MAY REQUIRE ME TO BE IN A REMOTE AREA NOT IMMEDIATELY ACCESSIBLE BY MEDICAL PERSONNEL. I understand that CPI and its affiliates do not possess the required training or equipment to handle incidents that may occur. In case of injury, accident, illness, or my inability to complete the Workshop, I will bear the full cost of any additional transportation or evacuation procedures performed by CPI or others on my behalf. I further covenant to reimburse CPI within 15 days of demand by CPI for repayment.
7. I hereby acknowledge that injuries received may be compounded or increased by negligent rescue operations or procedures of CPI and/or its affiliates and agree that this Agreement extends to all acts of negligence by CPI and/or its affiliates.
8. This Agreement and my release of CPI and its Affiliates SPECIFICALLY INCLUDES INJURY, DAMAGE, WHETHER PHYSICAL OR PECUNIARY, AND DESTRUCTION TO PERSON, PERSONS, OR PROPERTY WHICH MAY ARISE OUT OF, OR BE CLAIMED TO ARISE OUT OF NEGLIGENT ACTS AND/OR OMISSIONS OF CPI and its affiliates. I HEREBY RELEASE CPI from liability that might be imposed by law, or from such acts of others that CPI has not directed, adopted, or ratified.
9. It is my responsibility to obtain relevant and current travel documentation, including but not limited to ensuring I have the proper passport and visas relative to my circumstances and required by the destination to which I am traveling for the Workshop. Workshop pricing does not include airfare unless otherwise specified in writing by CPI. I acknowledge that hotel accommodations vary and I understand and accept the conditions and logistics relative to the Workshop. I UNDERSTAND THAT NO REFUNDS WILL BE GIVEN BY CPI OR ITS AFFILIATES IF I AM UNABLE TO ATTEND THE WORKSHOP BECAUSE I LACK PROPER TRAVEL DOCUMENTATION.
10. I accept that Workshop itineraries may change in the sole unfettered discretion of CPI. CPI reserves without prior notice the right to change or cancel parts or all of the Workshop. Further, CPI reserves the right to cancel without prior notice my attendance at the Workshop, or in a specific activity of the Workshop, if CPI in its sole discretion, determines that I fail to meet the requirements of the activities.



11. I have been provided instruction as to the safe handling of the equipment. I UNDERSTAND AND AGREE THAT I AM FINANCIALLY RESPONSIBLE FOR ANY LOSS OR DAMAGE TO MY BELONGINGS, BAGGAGE, AND PERSONAL AFFECTS, AS WELL AS THE EQUIPMENT OF CPI, ITS AFFILIATES, AND/OR ITS SUPPLIERS WHILE PARTICIPATING IN THE WORKSHOP. I ACKNOWLEDGE THAT CPI NEITHER INSURES WORKSHOP PARTICIPANTS NOR THEIR EQUIPMENT, NOR PROVIDES ANY INSURANCE COVERING ANY INJURY, HEALTH CARE PROBLEM, LOSS, OR OTHER NEED DURING THE WORKSHOP. I UNDERSTAND THAT CPI AND ITS AFFILIATES DO NOT OBTAIN INSURANCE THAT WOULD INURE TO MY BENEFIT. ANY AND ALL INSURANCES ARE MY SOLE RESPONSIBILITY TO OBTAIN.
12. CPI HEREBY HIGHLY ENCOURAGED ME TO OBTAIN TRAVEL INSURANCE. I UNDERSTAND THAT THE RESPONSIBILITY FOR ANY AND ALL TRAVEL INSURANCE, LIABILITY INSURANCE, MEDICAL INSURANCE, AND MEDICAL SERVICE IS DEPENDENT UPON MYSELF AND IS NOT THE RESPONSIBILITY OF CPI.
13. Whether the Workshop in which I am participating is held on private, public, or government lands, I agree to abide by all rules, restrictions, and ordinances governing such lands and property. I also agree to respect the rights of other Workshop participants, leaders, and those providing services to or for the Workshop. Failure to comply with any governing rules or authority may result in my dismissal from the workshop or related activity, with no provision for refund and full forfeiture of any monies I have paid or owe. Such dismissal is in the sole and unfettered discretion of CPI. If I am dismissed from the Workshop, and I still owe any monies to CPI and/or its Affiliates, those monies shall become immediately due and payable by me.
14. I understand that my reservation for attendance at the Workshop is not reserved for me until CPI receives full payment of the Workshop fee. Reservations are non-transferable unless agreed to in writing by CPI and another of this Agreement is signed by the new party.
15. I understand that CPI reserves the right to cancel the Workshop at any time and for any reason. CPI is not responsible for any cancelation-related expenses such as, but not limited to, non-refundable airfare. I accept that CPI will, in its sole and unfettered discretion and choice, use its best efforts to reschedule the Workshop, offer attendance at another Workshop, or to refund as much monies paid by me as possible.
16. I understand that my attendance at a Workshop requires advance commitment on the part of CPI and its Affiliates. I also understand that CPI wants me to be completely satisfied. Because of the nature of the advance planning required, Workshop fees paid to CPI and/or Affiliates are non-refundable except as provided herein. Workshop fees are not transferable and no refunds are made for unused or missed portions or services of a Workshop for any reason whatsoever.
17. I agree to notify CPI in writing of my desire to cancel by sending written notice via email to Addie Lorber at [addielorber@gmail.com](mailto:addielorber@gmail.com). The date of confirmation by Addie Lorber of receipt of my email shall serve as the date of my notice to cancel. If I desire to cancel, I accept the following with regard to refunds and cancelation fees:

Cancelation notice acknowledged as received by Addie Lorber:

- a. 120 days or more prior to Workshop start date will be subject to forfeiture of \$300 Workshop fee per person;
  - b. 119-61 days prior to Workshop start date will be subject to forfeiture of 50% of Workshop fee per person;
  - c. 60 days or less prior to Workshop start date will be subject to forfeiture of 100% of Workshop fee per person, unless my spot in the Workshop can be filled with someone else, and I accept that a discount may be offered and I will receive a refund of what the new person paid, less any non-refundable portions.
18. I hereby consent to the publication of my likeness even if for commercial purposes. Any and all photographs or motion pictures that include me or my property may be used by CPI and its assigns

in promotional and advertising efforts and I shall not be provided a fee or any other compensation for this use.

19. In the event that I in any way cause legal proceedings to be brought against any of the individuals identified in this Agreement, I agree to indemnify and to hold harmless those individuals for any claims advanced, including attorneys' fees and costs incurred in defending any claims which I bring or cause to be brought. I agree to indemnify CPI from any loss, liability, damage, or cost that they may incur, now and forever, arising out of or related to my participation, non-participation, and/or instruction in the Workshop, activities, or any other related activity, whether caused by the negligence of CPI, its Affiliates, or otherwise. This Agreement notwithstanding, if CPI should in any way become liable to me for any reason, the extent of CPI's liability shall be limited to the amount I have paid to CPI for the particular Workshop at issue. In no event shall the liability of CPI and/or its Affiliates extend to incidental costs incurred by me as a result of my inability to attend the Workshop, including but not limited to airfare, travel visa fees, clothing, equipment, miscellaneous transportation costs, medical expenses, travel insurance premiums or deductibles.

20. This Agreement may not be changed orally and is not related to any other documents. This Agreement shall be governed by the Laws of Florida and shall be effective wherever the Workshop is conducted, without regard for conflicts of law rules. If any provision of this Agreement is found to be unenforceable, that provision shall be replaced by a provision as similar in intent as possible. The remainder of the Agreement will be construed as if the unenforceable provision had never been included in this Agreement. Any ambiguities herein shall not be construed against the drafter. I acknowledge that the terms of this Agreement are subject to change by CPI.

I have read the foregoing, I understand it, and I sign below in agreement. I agree that in signing this Agreement I am bound by all of its parts and that if I am not prepared to be so bound, that I have the option of not participating in the Workshop.

I declare that I am of sound mind and full legal capacity, and I am not under the influence of alcohol, drugs, or any other mind altering substances that would affect the validity of this Agreement. I have not been coerced nor cajoled into signing this Agreement.
